- S. Webb seconded the motion to approve the minutes. All were in favor. Motion passed.

C. Principal's Reports

Principals provided updates on enrollment, school activities and nominated a governing board liaison for each location.

D. Information Items

- 1. Monthly Financial Report(s) (June FY 21; July FY 21)- Mr. Strader presented information on finance reports (June FY 2021, July FY 2021) as provided to the board.
- 2. FY 22 Title 1 Budgets- The board reviewed the FY22 Title 1 budget on behalf of the schools.
- 3. Involuntary Examinations Policy and Procedures, SB 590- The board reviewed the policy and procedures proposed by attorney Shawn Arnold.
